- 3) The bidder should agree to furnish a Bank Guarantee from a Nationalized Bank for up to 10% of the work and should have validity for the entire supply Period.
- 4) The bidder should agree to execute an agreement for proper supply and satisfactory quality of the containers exactly to the specifications mentioned.
- 5) The rates quoted should be FOR Gwalior. The prices should be inclusive of GST and other charges. However, the exact details of taxes should be given separately.
