1. Confirmation of the minutes of the IQAC meeting No. 16 held on 3rd December 2019

The minutes of the meeting No.16 was read by the IQAC Coordinator. The Action Taken Report was also submitted by the Coordinator. The Vice Chancellor appreciated the efforts of all the members in making all the actions possible. The minutes was proposed by Prof. S. K. Shukla and seconded by Prof. P. K. Tiwari.

2. Submission of IIQA and SSR

As NAAC validity period expires on 2nd March 2020, all members suggested to submit IIQA at the end of the year. All criterion chairman have been requested send information to IQAC for compilation of SSR.

3. Teaching on Virtual Platform

Under Covid-19 pandemic, all members suggested that teaching on virtual platform is a must and therefore annual licence for virtual platform must be taken at the earliest.

4. Strengthening of CoE

All members agreed to initiate second tender process for procurement of advance instruments under CoE. The central Purchase Committee will follow up the case.

5. MoU with New Institutions

For better academic interaction, members suggested to make new MoU with Agriculture University and Hotel Management Institute. Prof. GBKS Prasad will take the initiative in this regard.

6. Modular Education under NEP

The members discussed the modular education under NEP and suggested to make changes in the existing three years honours UG courses for four years NEP UG courses with multiple exit entry provision from the current session 2021-22.

7. Extension of Health Centre to 50 bedded hospital

The committee recommended expansion of Health Centre OPDs to IPD with the addition of 50 Beds and requisite Medical and Paramedical staff in the first phase.

8. Facilitation of start-up, incubation centre and skill development

As per NEP, members suggested that initiatives must be taken to empower Start-up ventures to boost entrepreneurship and employment for the students. The university should have a Start-up policy. In addition to this, members also recommended to open skill development and training programmes by the CIF.
