4. (a) Translate the following passage into Hindi—

Article 300 of the constitution says that the Government of India may sue or be sued by the name of the union of India and that State Government may sue or be sued by the name of the state. Thus, the constitution make the union and the states as juristic persons liable per owning and acquiring property, making contracts, carrying on trade or business, bringing and defending legal actions just as private individuals, the legal personality of the union of India or a state of the Indian union is thus placed beyond doubt by the express language of Article 300. The Government of India can be "sued" in relation to their affairs in the like cases as the dominion of India might have been sued if his constitution had not be enacted". As the Union of India is a legal person, it is not necessary to investigate whether the Government of India was a legal entity before the commencement of the constitution.
