

ORDINANCE NO. 22

BACHELOR OF COMMERCE

(Section 37(ii) and 39(i))

The courses of study for the degree of Bachelor of Commerce shall be of Three Academic Sessions and shall consist of three parts, namely :-

- (i) B.Com. Part I
- (ii) B.Com. Part II
- (iii) B.Com. Part III or B.Com. (Final)

(1) A candidate who after passing Higher Secondary Examination or Intermediate Examination under 10+2 pattern or M.P. Board of Secondary Education with Commerce Group or any other examination recognised by the University or M.P. Board of Secondary Examination as equivalent thereto, shall be admitted to the B.Com. Part I Examination.

There shall be a University Examination at the end of each part ordinarily in March/April in each year and the candidate shall have to pass separately in each part before he can be deemed to be qualified for obtaining the B.Com. Degree.

- (i) There shall be Supplementary Examination ordinarily in August/September each year.
- (ii) The following shall be eligible to appear at the supplementary examination :-
 - (a) Candidate who have failed in one group or subject or paper as the case may be.
 - (iii) A candidate who has been declared eligible for a supplementary examination candidate in the two examinations immediately following the examination in which he/she was declared to be so eligible and there after he/she be required to appear in all the papers/subjects or Group at the examination.

Subject to the provision of this Ordinance, the scheme of examination, the syllabus and text books, if any, to be prescribed or recommended in connection with the subject or Group for any of the examination covered by the Ordinance and the conditions on which the students shall be admitted to such examination, shall be in accordance with the Provisions made by or under the regulations to be made by the Academic Council after considering the recommendations of the Board of Studies and the Faculty of Commerce.

For the purposes of the provision contained in the Ordinance relating to Examinations (General) " Regular course of Study " means attendance of at least seventy five percent of lectures delivered in each subject or courses of instructions at the end of the First Year, Second Year and Third Year, the attendance being calculated upto a date two weeks immediately preceding the date of the commencement of the written examination.

A candidate shall not be allowed to appear in any other Academic examination with his/her B.Com. Part I, B.Com. Part II or B.Com. Part III/Final Examinations.

A candidate shall be declared successful if he/she secures 33 % percent minimum pass marks required in each subject or Group as the case may be and in aggregate of each subject or Group in B.Com. Part I, B.Com. Part II and B.Com. Part III or Final.

Division shall not be assigned to a candidate on the result of the B.Com. Part I and B.Com. Part II Examinations. Marks of the B.Com. Part I, B.Com. Part II and B.Com. Part III (Final) shall be counted together for a place on the pass list of the B.Com. Final Examination. Division shall be assigned on the following basis, namely :-
