



## Statute No. 15

### **Registration of Graduates (Refer Section 46)**

1. Persons entitled to registration in the Register of Registered Graduates under section 46, shall apply to the Registrar of the University in the form 'A' given in the Appendix.

2 (i) "Registration of registered graduates shall be for a period of three years on payment of a fee of Rs. 100/- alongwith an application in the prescribed form. This registration shall be renewable for a further period of 3 years and such renewal shall be done on payment of a fee of Rs. 40/- for every renewal in the prescribed form given in appendix B.

(ii) Application for renewal shall be made not later than 30 days after the expiry of the registration of the graduate and in case renewal application is made within the prescribed time the registration of the graduates shall be renewed for three years. In case the application for renewal is not received within the prescribed period the name of the graduate shall be deleted from the register of registered graduate and the Registrar shall authenticate the deletion. After the name is deleted the concerned graduate will be required to register himself afresh on payment of a full fee of Rs. 100/- and an application in the prescribed form given in appendix 'A'.

Provided that a registered graduate whose name stands in the register of registered graduates on the date on which this amendment is approved by the co-ordination committee, (herein after called the appointed date) shall continue to be a registered graduate upto one year after the appointed date or three years from the date of his registration whichever is later. Such graduates will be required to submit an application for renewal in the prescribed form given in Appendix 'B' with a renewal fees of Rs. 40/-

3. Application for registration may be made at any time during a year provided that only those graduates who are either registered or re-registered graduates of the university 90 days prior to the date of election of registered graduates for the membership of the Court, shall be eligible to stand as candidate for and vote at such election.

4. For the purpose of enrolment in the Register of Registered Graduates:-

(a) The period of three years standing shall be reckoned from the date on which the applicant's degree was signed by the Kulpati or other competent authority of the University.

(b) The following evidence shall be produced by the applicant in support of graduation

(i) his degree or copy thereof duly attested by a Gazetted Officer or a Professor or a Principal of a college; or

(ii) a certificate from the Registrar of the University conferring the degree to the effect that he has been admitted to the degree, or

(iii) the calendar or other authorised publication of the university.

(iv) any other evidence to the satisfaction of the Registrar. ✓



(v) Three passport size photographs of the applicant duly attested by a Gazetted officer or a Professor or a Principal of a College.

(c) The following evidence shall be produced in support of residence, viz.: -

1. A certificate from: श्रीमान् श्री वि. वि. वि.
  - (i) A Statutory Officer of the University. \_\_\_\_\_
  - (ii) A Principal of a College in the University. \_\_\_\_\_
  - (iii) A Professor, College Professor or Reader of the University.

2. Such other evidence of residence as may be accepted as satisfactory by the Registrar in this behalf. \_\_\_\_\_

5. The name of the applicant, if he is duly qualified and has paid the enrolment fee, will be entered in the Register.

6 (a) The Registrar shall maintain in his office the register of Registered Graduates showing their names and addresses including place of residence and districts, name of the degree and the year of award of the degree together with name of the university which awarded the degree with the signature of Registrar against the entry at each name in the register. The register shall be open for inspection.

(b) There shall also be maintained an album containing duly attested photographs of all the Registered graduated in alphabetical order which shall be open to inspection.

1. Every Registered Graduate shall intimate to the Registrar all changes in his permanent address.

2. The Registrar shall by a notice sent along with one blank form B (as given in the Appendix) to each person registered as a Registered Graduate of the University on the date on which the Adhiniyam came into force and in such newspapers as the Kulpati may approve, call upon every such Registered Graduate to declare if he is enrolled as a Registered Graduate of any other Univeristy and to exercise under Section 45 of the Adhiniyam his option, if necessary, to continue as a Registered Graduate of the University. Such declaration and option shall be sent to the Registrar so as to reach him on or before the 4th November, 1973.
