

ORDINANCE NO. 23

MASTER OF COMMERCE

(Sec. 37(1a) and 39(i))

- (i) The courses of study for the degree of Master of Commerce shall consist of two parts.
- (ii) The first part extending over one academic session shall be referred to as the "Previous" and second part as the "Final Examination" or according to semester system as per examination as per Ordinance No.
- (1) A candidate who, after taking his/her Bachelor's Degree in Commerce of this University or of any Indian University recognised for the purpose by the Academic Council of this University shall be admitted to the Previous Examination for the Master's degree of Commerce. Candidates after passing the previous M.Com. Examination of this University, shall be admitted to the final examination for the degree of Master of Commerce.

Provided a candidate who has passed his/her previous M.Com. Examination for the Degree of Master of Commerce from another University may also be admitted to the Final Examination for the degree of Master of Commerce subject to the condition that he/she offered for his/her previous examination a course equivalent to the standard with almost identical syllabus as is required for identical previous examination of this University and his/her eligibility has been approved by the University.

- (ii) A candidate, who has passed in M.Com examination of the University shall be allowed to present himself /herself for examination in any one or more of the optional papers in the subject not taken by him/her at the said examination and if successful, will be given a certificate to that effect.

Provided that no candidate shall be allowed to offer more than two papers in any year.

3. There shall be a University Examination at the end of each part ordinarily in March/April in each year and the candidate shall have to pass separately in each examination before he/she can be deemed to be qualified for obtaining the M.Com. Degree.

- (i) Subject to the provisions of the ordinance, the scheme of examination and the syllabus and text books, if any, to be prescribed or recommended in connection

with any subject for any of the examination covered by this Ordinance and the conditions on which the students shall be admitted to such examinations, shall be in accordance with the provisions made by the Academic Council after considering the recommendations of the Board of Studies and the Faculty of Commerce.

For the purposes of the provisions contained in the Ordinance relating to examination (General) " Regular Course of Study " means attendance of atleast Seventy Five percent of lectures delivered in each subject or the course of instruction for the respective examinations at the end of the previous year and the Final Year, the attendance being calculated upto a date two weeks immediately preceding the date of the commencement of the written examination.

Candidates may appear as non- collegiate candidates in M.Com. Previous and Final Examination.

A candidate shall have to obtain atleast 20 % marks in each paper and 36 % of the total marks in all the four papers to pass a Previous and a Final Examination.

No Division shall be assigned on the result of the Previous examination. Marks of the Previous and Final Examination shall be counted together for a place on the pass list of the Final Examination. Division shall be assigned on the following basis namely :-

First Division	60 % and above
Second Division	48 % and above
Third Division	36 % and above
