#### ORDINANCE NO. 28

#### BACHELOR OF LAWS (LL.B.)

(Sec. 37(11) and 39(1))

The ordinance provides for admission, examination and other incidental matters regarding LL.B. Degree Course which is a three academic years integrated professional course. These three years are known as -

LL.B. First Year.

LL.B. Second Year and,

LL.B. Third Year.

### DMISSIONS:

A candidate who holds a graduate or post-graduate Degree of this University or of any other University recognised by this university as equivalent thereto with atleast 40 % marks in theory papers of all the University examination of all the Years of Degree course may apply for admission to LL.B. first year course.

Provided a relaxation of Half percent of marks, i.e. upto 39.5 % marks, may be given to the applicants if the seats are available and college rules permit such admission.

Provided further, a relaxation of Five percent of marks, i.e. upto 35 % marks, may be given to S.C./S.T. applicants.

A candidate who passes LL.B. First Year Examination of this University or of any other University recognised by this University as equivalent thereto as collegiate candidate may apply for admission to LL.B. Second Year Course.

A candidate who passes LL.B. Second Year Examination of this University or of any other University recognised by this University as equivalent thereto as collegiate candidate my apply admission to LL.B. Third Year Course.

A candidate who is eligible to appear in supplementary examination may apply for provisional admission to the next higher class of LL.B. Such admission shall be automatically cancelled of the candidate does not clear the examination.

All admissions to First Year, Second Year, and Third Year of LL. B. Degree course must be completed by 1st July every year provided the Principal may admit a student till 31st July at his discretion and for special reasons with the permission of Kulapati by 14th August. No admission is permitted thereafter on any ground whatsoever. The candidates who are eligible to appear in supplementary

examinations of LL.B. First or Second Year must seek provisional admission in the next higher class during the above noted period. If the result of annual /main examination of Final year of Graduate or Post-Graduate class or of LL.B. First or Second year of this University is declared after 14th August then the admission must be completed within seven days from the date of declaration of result excluding holidays.

LL.B. Degree course is a full time course. An admitted student to the LL.B. Degree course is not permitted to take admission in any other course leading to a Certificate or Diploma or Degree alongwith LL.B. Degree Course except Language Diploma course.

A candidate who has passed LL.B. First Year or Second Year Examination from other University which is recognised by University as equivalent thereto as collegiate candidate may be admitted to the LL.B. Second Year or Third Year course as the case may be on the condition that the candidate shall be required to pass in those paper/papers of LL.B. First Year or Second Year of this University which the candidate has not passed in the LL.B. First Year or Second Year Examination of other University. He should clear such paper/papers alongwith the LL.B. Second Year or Third Year in which he takes admission. However such a candidate need not fill a separate examination form for clearing First or Second Year paper/papers. However, candidate will be exempted from such paper/papers of LL.B. Second Year or Third Year course of this University which he has passed in LL.B. First Year or Second Year course of other University. The aforesaid exemption shall be made keeping in view the existing scheme of examination and courses of studies.

A candidate who has passed LL.B. Previous of Two Years Degree course may be admitted to LL.B. Second Year of Three Years Degree course. Such a candidate will have to clear the paper/papers of LL.B. First Year of Three Years Degree course which he has not learned in LL.B. (Previous) of Two Years Degree Course alongwith LL.B. Second Year of Three Years Degree Course. However, he will be exempted from the paper/papers of LL.B. Second Year or Third Year of Three Year Degree Course which he has cleared in LL.B. (previous) of Two Years Degree Course. Such exemption shall be made keeping in view the existing scheme of Examination and courses of studies. Such a candidate need not fill a separate examination form for clearing LL.B. First year paper/papers.

A candidate who has failed in LL.B. (previous) or (final) of Two Years Degree course may be admitted to LL.B. First or Second Year of Three Year Degree Course as the case may be. He cannot be treated as ex-student of LL.B. First or Second Year of Three Years Degree course. Hence, marks of

paper/papers of such failed candidate will not be carried forward even if they are 48 % or above individually.

The admission of a candidate in LL.B. First or Second or Third Year of this University in the mid-term who has already taken admission in LL.B. First or Second or Third Year of other University recognised by this University as equivalent thereto may be permitted if he fulfills the admission qualifications of LL.B. First, Second or Third Year of this University, if the courses of studies of other University of the relevant year are substantially the same, if he satisfies the attendance requirement, if the seats are available in the college and if the college rules permit such admission.

LL.E. Degree course is not open for non-collegiate andidates.

## XAMINATIONS :

A candidate who prosecutes a regular course of study prescribed for LL.B. First Year for one academic year in the law department of a college subject to the jurisdiction of this University may be allowed to appear in LL.B. First Year Examination.

A candidate who prosecutes a regular course of study prescribed for LL.B. Second Year for one academic year in the Law Department of a college subject to the jurisdiction of this University may be allowed to appear in LL.B. Second Year Examination.

A candidate who prosecutes a regular course of study prescribed for LL.B. Third Year for one academic year in the Law Department of a college subject to the jurisdiction of this University may be allowed to appear in LL.B. Third Year Examination.

A candidate who passes LL.B. Third Year Examination of this University as a collegiate candidate and also LL.B. First Year and Second Year Examination as collegiate candidate shall be eligible to obtain LL.B. Degree from this University.

The University shall conduct an annual / main examination at the end of academic year for each year of LL.B. Degree course ordinarily in the months of March/April in all the papers of the year.

The University shall conduct supplementary examination after the annual/main examination ordinarily in the months of August/September for each year of LL.E. Degree course in one paper.

A candidate who obtains 36 % marks in all papers except one of LL.B. First or Second or Third Year and an aggregate of 48% of marks of such papers or a candidate who obtains 36% marks in all the papers of the LL.B. First, Second or Third year but does not obtain an aggregate of 48% marks of such papers shall be eligible to appear in supplementary examination in one paper.

A candidate shall appear in the supplementary examination in that paper in which he has obtained less than 36 % marks. However, if the candidates has obtained 36 % or above marks in all the papers of the years then he shall appear in any one of the papers in which he has obtained less than 48 % marks individually.

A candidate is exempted from reappearing in paper/papers in which he has secured 48 % or above marks individually. The marks of such paper/papers shall be carried forward.

A candidate who is not eligible to appear in supplementary examination or who does not clear supplementary examination is fail if he desires to take examination he shall appear in the annual main examination as ex-student in paper/papers in which he has secured less than 36 % marks individually. He may at his option reappear in paper/papers in which he has obtained less than 48 % but above 36 % marks individually to wover the aggregate and/or to enhance the percentage of marks. If he appears in such paper/papers his earlier marks of such papers shall be deemed to be cancelled.

He can also reappear in the supplementary examination. This process can be continued till the examination is passed.

The minimum pass marks for each year of LL.B. Degree course are 36 % in each paper and 48 % in the aggregate of all the papers.

A candidate of LL.B. First, Second or Third year examination shall be entitled to a benefit of Grace marks up to the maximum of three marks per year of LL.B. in theory and practicals in theory this benefit is available in one or more papers individually (in minimum) or in aggregate or partly in such paper or papers and partly in the aggregate to pass the annual/main and supplementary examination. In practicals, this benefit is available in record or viva voce or both to pass the annual/main and supplementary examination. However, added in the total of paper or papers individually or in the aggregate or in the Record or Viva-voce. This grace and the Vice-Chancellor's grace of one mark for passing or for division cannot be availed simultaneously.

The division shall be assigned to successful candidates on the basis of marks obtained in the papers of first year, second year and third year examinations of LL.B. Degree course as under:

First Division with distinction 75 % and above marks (including Grace marks if obtained.)

First Division - 60% and above but below 75% marks (including grace marks if obtained.)

Second Division - 48 % and above but below 60 % marks (including Grace marks if obtained)

The candidates taking First, Second or Third Year examination shall answer the questions either in Hindi or in English language.

The scheme of examination, the course of studies and the rules of examinations which are applicable to regular students shall apply to ex-student except those which are made specifically applicable to them.

The sessional, tutorial, legal writing, practical training and the like marks obtained by a candidate of other University in LL.B. First or Second year shall not be counted for the purpose of division as they are not provided in this University.

The candidates who are existedents of LL.B. first year and second year or of second year and third year simultaneously under ATKT scheme of examination may appear in the main supplementary examinations of both year simulataneously with those paper/papers offered by them as regular candidates till they clear the examinations. In case such paper/papers are deleted or changed, they may appear with the alternate paper/papers as ex-students. However they must fill separate examination forms for both the years.

A female candidate who is qualified to take admission in the LL.B. Degree course as a collegiate candidate may appear in all the three years' examinations of LL.B. Degree course is non-collegiate candidate. The scheme of examination except practical training, course of studies and other rules of examinations applicable to collegiate candidates will apply to her.

Actual marks obtained by the candidate in the main and in the supplementary examinations either as regular or as exstudent will be counted for passing, aggregate and division.

All the regular students of LL.E. Third year are required to undergo practical training in law and to keep its record

the form of files. The record shall be valued and viva Voce examination shall be conducted on the practical training in law by a board of examiners consisting of an internal and an external examiner to be appointed by the University. The Head of the Law Department shall be the internal examiner. In his absence other teacher of the Law: Department may be appointed as internal examiner. If no teacher of the Law Department is available then external alone will conduct the viva-voce examination. The minimum pass marks for record and for viva-voce are 18% separately. The marks shall be awarded by consensus of examiners. In case of difference of opinion between examiners the total marks both of record and viva-voce shall be divided between the examiners and shall be awarded by them individually. The awarded/marks on record and viva-voce by both the examiners shall be totalled in each case. These totals shall be the practical marks of candidates. If a candidate obtained 18% or more marks in each, these marks shall be carried forward if he fails in theory papers. If a candidate obtains less than 18% marks in record or viva voce or in both he is fail even if he passes in theory papers. Such a candidate will have to reappear in record & viva voce both. For this purpose he has to undergo practical training again in the college with due permission. Practical training in law is treated as a subject for the declaration of result. However, the marks obtained in practical training in law will not be counted for aggregate and division.
